Earl Baldwin of Bewdley

Lord Baldwin is chairman of the Parliamentary Group for Alternative and Complementary Medicine and chair of the British Acupuncture Accreditation Board. He has made many vital contributions in Parliament to debates on health care and has a regular column in the Journal of Alternative and Complementary Medicine. He has a background in education and teaching.

The Lord Norrie

Lord Norrie has contributed extensively to Parliamentary work on environment and health issues and has a special interest in holistic health and in the care and treatment of kidney patients. His Private Members Bill to make swimming part of the National Curriculum in schools was adopted by the Government and came into force in 1996. He served as a member of the House of Lords European Communities Committee on the Environment for four years, and was the House of Lords winner of the 1993 Green Award for contribution to the environment. He has been President of the British Trust for Conservation Volunteers since 1987, and is a Vice-President of the Council for National Parks. He is also a council member of the Winston Churchill Memorial Trust, and UK Patron of the Royal Life Saving Society since 1993.

Manibhai Talashibhai Patel, MBE

Manibhai Patel, a prominent Ugandan Asian, is a founder member of the Social Democratic Party and an elected member of the Council for Social Democracy, the SDP's policy making body. He is a member of the Asian Liberal Democrats. He has a keen personal interest in the welfare of all immigrants in the UK and is an active trustee of Immigrant Aid within the joint council for Welfare of Immigrants. He supports many charities in the UK and India including Home Farm Trust for disabled children and the Princes Youth Business Trust.

Dr Bhatt has worked and taught undergraduate and postgraduate students at leading medical schools in England and abroad for the past 30 years. He was until recently head of the prestigious Vitamin B12 Unit at Charing Cross and Westminster Medical School. He is one of the few recognised world experts involved in advancing the fundamental understanding of the role of key vitamins in the development of the brain and nervous system. He has pioneered the treatment of infants and children suffering from devastating neuro-metabolic diseases. SCIENTIFIC AND MEDICAL ADVISERS

Professor Donald Barltrop, MD, BScHons, FRCP, FRCPCH

Professor Barltrop is head of Academic Department of Child Health at Chelsea and Westminster Hospital within the Imperial College School of Medicine, London. He is also a Fellow of the American College of Nutrition. His research interests include environmental hazards for children, with special reference to toxic trace metals and nutrition. He has published, edited and contributed to 11 books and over 90 original papers in leading medical and scientific journals.

Professor Franco Bottazzo, MD, FRCP, FRCPATH

Professor Bottazzo is the discoverer of islet cell antibodies, which are used, in the early diagnosis of type one diabetes. His prolific research contributions - over 200 original papers - are widely quoted by all international experts. Having worked and taught in leading medical schools in England and Italy for the last 25 years, he is currently the head of Department of Immunology at The Royal London and St Bartholomew's Hospitals. He has won major prizes in diabetes including the Banting Memorial and RD Lawrence and the Minkowsky awards.

Dr Sarah Eagger, MBBS, MRCPsych

Dr Eagger is senior lecturer and honorary consultant psychiatrist for the elderly at the Division of Neuroscience and Psychological Medicine, Imperial College School of Medicine. She has pioneered research on the first licensed treatment for Alzheimer's disease at the Maudsley Hospital, London. Dr Eagger has a longstanding involvement in holistic health and is currently chairperson of the British Holistic Medical Association. She is concerned with the application of holistic principles and their implications in the education and training of doctors.

Dr Peter Fenwick, MB, Bchir, DPM, FRCPsych

Dr Fenwick is senior lecturer at the Institute of Psychiatry, London, consultant neuropsychiatrist at John Radcliffe Infirmary in Oxford, and honorary consultant in neurophysiology to Broadmoor Special Hospital. He has published numerous scientific papers on brain function and also several papers on meditation and altered states of consciousness. His most recent book is 'The Truth in the Light'. Dr Fenwick is also chairman of the Scientific and Medical Network, a group of doctors and scientists seeking to deepen understanding in science and medicine by fostering intuitive as well as rational insights.

Dr Mehta is the surgeon and chief of head and neck services at Tata Memorial Hospital in Bombay, India. He is also the head of oncology at Nanavati Hospital and Medical Research Centre, and honorary cancer surgeon at the Jaslok Hospital and Medical Research Centre, Bombay. Dr Mehta has been a pioneer in continuing medical education in India, first introducing the concept to the Association of Surgeons of India in 1974. He was president of the association in 1986 representing seven speciality sections besides general surgeons. He is the medical director of Global Hospital and Research Centre, Mt Abu.

Dr David Peters, MB, ChB, DRCOG, MFHom, MRO

Dr Peters is a registered medical practitioner and Osteopath and member of the Faculty of Homeopathy. For the last 10 years he has been directing the Complementary Therapies' service delivery and research unit at Marylebone Health Centre and Inner City General Practice set up with the aim of developing approaches in primary care. He is Director of Complementary Therapy Studies in the Centre or Community Care and Primary Health at the University of Westminster and interdisciplinary unit, whose programmes include four undergraduate degrees and two post graduate programmes. He is the co-author of the new Encyclopaedia of Complementary Medicine. His team at Marylebone Health Centre, have just completed the first year of a four-year project on the impact of complementary therapies on NHS General Practice.

Dr Raval is Professor at the Brooke Medical Center in San Antonio, Texas.
